- Performs analytical work according to specified procedures and assists in carrying out special assignments according to general instructions.
- Operates full range of basic and complex laboratory equipment and apparatus used in environmental laboratory analytical work, including computers, automated equipment and related software.
- Prepares reports of field or laboratory work, calculates results of tests, and enters data into manual and automated recording systems.
- Prepares chemical solutions, reagents, stains, and media in order to perform a variety of laboratory and research tests.

Education and Experience

Minimum Requirements:

Any combination of training and experience which would provide the required knowledge and ability is qualifying. A typical way to obtain the requisite knowledge and abilities would be:

1. One year of progressively responsible laboratory experience performing tests in chemical, bacteriological, or public health; AND
2. Twenty-four (24) semester hours in college or university laboratory courses such as chemistry, physics, biology, or bacteriology.

License Requirement:

Possession of a valid California Driver's License, Class C or higher.
